SUBSCRIBER AGREEMENT

The terms & conditions herein contained shall constitute a legally valid and subsisting agreement between STAR VISION and the Subscriber (named in the application form) and their respective assignees/heirs/executors/administrators. As the case may better availing cable TV Services either directly and/or through its linked cable operators in DAS notified areas. The conditions mentioned are understood and accepted by the Subscribers and shall be applicable for the Subscriber on signing of the SAF Form/availing of the Service.

DEFINITION

(I) "Addressable system" means an electronic device (which includes hardware and its associated software) or more than one electronic device put in an integrated system through which signals of cable television network can be sent in encrypted form, which can be decoded by the device or devices, having an activated Conditional Access System at the premises of the subscriber within limits of the authorization made, through the Conditional Access System and the subscriber management system, on the explicit choice and request of such subscriber, by the STAR VISION to the subscriber.

(II) "Broadcaster" means a company from which STAR VISION sources its programming service/channels and includes its authorized distribution agencies. (III) "Cable Operator" means any person, duly authorized by STAR VISION, who provides Services through a cable television network to the subscribers after receiving the same from STARVISION. (IV) "Channels" means such satellite based free-to-air & pay television channels, radio channels, local cable channels and other related value added services as may be subscribed by the subscriber and which shall be authorized & distributed by STAR VISION as part of 4s service in encrypted mode which can be viewed by the subscriber only by means of the STB.

(V) "Pay Chamer in respect of a cable television network, means a channel for which subscription fees is to be paid is the broadcasters by STAR VISION and due authorization needs to be taken from the broadcaster for its re-transmission.

(VI) "DAS" area means the areas where in terms of notifications issued by the Central Government under sub-section (I) Of section 4A of the Cable Television Networks (Regulation) Act, 1995 (-7 of 1995), it is obligatory for every cable operator to transmit or re-transmit programmes of any channel in an encrypted form through a digital addressable system.

(VII) "Permitted Viewing Device" means either a viewing device and/or a hearing device which is specifically permitted, being television and personal computer.

(VIII) "Programme" means any television broadcast and includes-(a) exhibition of films, features, drama, advertisements, serials; news & current affairs; (b) any audio or visual or audio-visual live performance or presentation and the expression "programming service" shall be construed accordingly; (IX) "Service" means the digital addressable cable TV services provided by STAR VISION and any value added services as may be authorized directly at the Subscribers Premises through the STB. In accordance with the Subscription Request

(X) "STARVISION" means STAR VISION.

(XI) "Subscriber Premises Equipments" or "SPE" means Set Top Box, Viewing Card, remotes and other equipments given by STAR VISION or as linked cable operator to the subscriber so as to enable him/her/it access the services on Permitted Viewing Device (PVC).

(XII) "STB" (Set-top-box) means a device, which is connected to, or is a part of a PVD and which is compatible with and allows a subscriber to receive in unencrypted and descrambled form subscribed channels through an addressable system regardless of its brand or manufacture or acquisition source to enable subscriber to view the channel.

(XIII) "Subscriber Application Form" or "SAF" means the standard form of subscriber application form (SAF) to enable prospective Subscriber to subscribe to the Service by duly filling. Signing by accepting the Terms & Conditions mentioned overleaf to it and submitting it to STARVISION and/or as authorized cable operators.

(XIV) "Subscriber Premises" means the Installation location specified by the Subscriber in the SAF where STB will be installed to view the Service directly using one and only one Permitted Viewing Device.

(XV) "Subscription Request" means the Channel (s) and/or bouquet of Channels and applicable left plan! Schemes selected by the Subscriber by filling of the requisite SAF manually or through any electronic mode or any modification/amendments effected therein from time to time.

TERMS

(I) Agreement commences upon installing STB, activating the viewing card (VC) and shall remain in force. Subject to applicable terms based on the Subscription Request by the Subscriber. STAR VISION reserves the right to reject the Subscriber Form for any reason. Any money paid by the subscriber shall not create any right in favor of subscriber until activation of the VC. In addition, STAR VISION reserves the right to discontinue the Service even after activation without any liability save and except for refund of money paid by the Subscriber towards subscription/activation, rental, Hire Purchase value and the VC deposit as the case may be. The Subscriber represents that he/she has been fully informed about the Cable Television Services provided by STAR VISION. Its specifications, requirements, limitations, etc. and have only thereupon opted for such services. Filled up and submitted the subscriber form, and sign the Agreement. (ii) STAR VISION shall perform its obligations and do inspection under this agreement including collection of subscription charges, deposits, rents either through its employees or through its authorized cable operator or any other authorized representative. (iii) The Subscriber hereby confirms that the STB has been examined, inspected and demonstrated to him as in good working conditions to the satisfaction of the subscriber. No claim or objection shall hereafter be admissible against STAR VISION or its authorized cable operator as to the quality & functioning of STB. (IV) In case of any change, revision in the terms by TRAI (Telecom Regulatory Authority of India), the same shall become applicable to this agreement from the date of notification by MAL

THE SERVICE

(I) The Service shall be based on the Subscription Request and provided to the Subscriber subject to any regulatory government control and intervention in respect of the Service.

(II) The Subscriber shall be provided a SPE to enable the Subscriber to access the Service, on the Terms & Conditions of this Agreement, including any modifications, alterations. Additions and substitution therein, from time to time. (iii) In case subscriber has not purchased the SPE, he/she/it hereby acknowledges and agrees that he/she/it shall not acquire right, title and interest in the SPE and that the SPE shall be returned by the Subscriber upon termination/determination hereof, and/or deactivation or temporary suspension of the Service. However VC shall always remain the sole property of STAR VISION.

(iii) The Channels/package of Channels and the respective charge/rates available for commercial and residential subscribers are different and a commercial/residential Subscriber can choose the Channels/package of Channels as per the prevalent scheme (a) For change or addition, deletion, substitution, modification of the Subscribed Service, the Subscriber shall submit the requisite form together with the applicable processing fees charges at least 15 days in advance to enable processing of the same and be provided by the additional terms as may be applicable. Any change or withdrawal from the Subscribed Service shall not entitle the Subscriber to any refunds or adjustments of the monies already paid, billed or to be billed under the additional terms.

(vi) (a) The Subscriber is bound to pay at least one month charges/bill for the Subscribed Service with or without modification as stipulated above and he/it shall not be entitled for any refund/adjustment even if he/it opts out from such Service(s) before the expiry of one month. (b) Notwithstanding anything mention in Clause (a) above, where the subscriber has opted for a channel on ala-carte basis for a period less than three (3) months then the subscriber shall pay for three months thereafter referred to as "Lock-in-Period") of the price of the opted channel. The subscriber shall be liable to pay price of opted channels for Lock-in-Period even if he opts out from such Service or hire Service are deactivated in terms of this Agreement. Before the expiry of such lock-in-period. (c) The Subscriber can submit Subscription Request for the Services and/or update the Subscribed Service(s) by way of an add-on or substitution or deletion etc. of Channels and/or update its personal information by logging to www.stvcable.com and/or by any other electronic medium as may be specified from time to time. (d) The Subscriber shall be responsible for safe custody of SPE and also of VC number 6 STD number and/or password provided by STAR VISION and shall be liable for the payment or subscription charges/entire billing amount pursuant to provision of Service(s) by STAR VISION as per subscription request. STAR VISION may at its sole discretion continue to provide Services for a period of 15 days or more (hereinafter referred to as "grace period") even after the due date of subscription payment in order to facilitate the Subscriber to make payment. However such grace period, if/when provided by STAR VISION shall not be construed as right of the Subscriber and in case of deactivation of Services of the Subscriber due to payment default even in grace period, the Subscriber shall be liable to make the payment for the period during which he/she has availed the Services including the Services availed during the grace period along with twelve percent interest per annum. (vi) The Service quality, functionality, availability and/or reliability thereof may be affected for reasons beyond the control of STAR VISION. In such event, STAR VISION is entitled to, without any liability, refuse, limit, suspend, vary, disconnect deactivate and/or interrupt the Service in whole or in part at any time in its sole discretion with respect to one/all Subscriber(s) without any notice for any reason and/or due to various factors including but not limited to (a) applicable law and/or directives of any authority/court; (b) Transmission limitations/problems caused by topographical, geographical, atmospheric hydrological, environmental conditions, and/or mechanical conditions and/or such other factors/features/conditions, system(s) changes or capacity limitations for reasons up gradation variations, installation, relocations, repairs, operation and/or maintenance of systems/equipments or the Services; (c) the requirement to combat potential fraud, sabotage, willful destruction, etc. (d) for any legitimate business purposes; (e) on breach of any term of this Agreement; (f) force majeure circumstances, Act of God; (g) incompatibility with SPE; (h) any delay in payment of any dues by the Subscriber. In case of suspension/disconnection, etc. reconnection/reactivation may be affected by STAR VISION in its sole discretion subject to its satisfaction and on such other/further terms as STAR VISION may determine. (viii) The Services provided in terms of this Agreement shall be as prevalent in the market which can be changed at the sole discretion of STAR VISION. (ix) The SPE provided to a Subscriber shall, all times, remain the property of STAR VISION. Except in cases where STB has been purchased by the Subscriber. STAR VISION shall not be liable for any incidental damage to the Subscriber or the Subscriber Premises from the use of SPE. The Subscriber shall take proper care of SPE and ensure its maintenance in proper working condition at all times. The SPE should not be given on loan/hire or transferred to anyone else. (a) In case, the SPE has been procured under a scheme in which the SPE was on security deposit basis, the refund of security deposit shall be subject to return of the SPE in proper working condition and submission of original receipt duly stamped by STAR VISION at the above address; provided the STAR VISION Subscribed Service is continued till the time the refund of security deposit is claimed and there is no default in payment of applicable charges towards the Services during the tenure of this Agreement. In ca, the SPE procured under the rental scheme, the refund of unexpired portion of the rental amount, if any, shall be made after deducting the proportionate rental amount representing period of use of SPE under the rental scheme, the cost of installation and distribution cost applicable taxes/levies subject to return of the SPE in proper working condition. (xi) STAR VISION is entitled to change, vary, add, withdraw the Subscribed Services, or part thereof and/or to vary the price relating thereto, which shall be binding on the Subscriber, and remains always subject to applicable law and/or directives of any authority/Courts. Request for any Services in addition to existing Subscribed Service shall be at extra costs and on such other / further terms as are specified from time to time (xii) The Subscriber hereby acknowledges and agrees that depending upon different Subscribed Service chosen by various Subscriber(s), the Prices and Terms & Conditions applicable thereto may be different. (xiii) STAR VISION shall be responsible for any defect (other than the defect due to any unauthorized or improper use, replacement, removal, modification, tampering, misuse, negligence or failure to follow the prescribed instructions) in SPE or any equipment/accessories forming part of SPE during the warranty period. (xiv) STAR VISION reserves absolute right not to broadcast any Channel if it is anti-national or against communal harmony or is pro-motote political/religious propaganda or it banned restricted or prohibited unclay - any law for the time being in force or for any other reason which STAR VISION feels it is not in the interest of its viewers or society. (xv) SIT/CABLE and/or its authorized cable operators are entitled to carry out the inspection of the Subscriber Premises to verify the compliance with/fulfillment of the conditions stated herein on the part of Subscriber and shall be entitled to take photographs, Documents materials, equipments etc. as proof of violation of this Agreement and/or infringement of any intellectual property rights of STAR VISION. The instances of piracy or violence of any intellectual property rights and/or unauthorized viewing of she Channels as detected against the Subscriber by finger printing mechanism and/or any other mechanism/method system deployed by STAR VISION for such detection shall be valid and acceptable to and uncontested by the Subscriber. Subject to the applicable laws/rules/regulations for the time being in for. STAR VISION shall have rights to immediately disconnect the Service, de SPE reported to have been involved in piracy. STAR VISION shall have no liability whatsoever for disconnection of the Services by STAR VISION under the said regulations. (xvi) I This SAF provides option to the Subscriber to choose from various options to avail SPE from STAR VISION. The Terms & Conditions of the SPE options are also available on the website of STAR VISION within two (2) days of receipt of bill /statement of subscription charge /charges, any discrepancies in billing (XVII) Subscriber can procure an STB of approve quality (as specified by Bureau of Indian Standards) from any source provided the same shall be compatible with STAR VISION's network. (xvii) The STB shall be solely used for availing STARVISION services and shall not be used for availing services of any other cable television service provider (xviii) The STB shall have only one year warranty from the date of installation at the subscribers premises.

OBLIGATIONS OF SUBSCRIBER

(I) To deposit bills raised and payments thereat in such mode as may be notified from time to time, within the due dates of payments mentioned in the bills, either at the centers publicly informed and notified by STAR VISION for the collections of bills by way of depositing the billing amount in designated Bank Account, or by paying the same to the authorized persons / cable operators,

(ii) To use only such STB and apply only such VC issued for such SIB, as specified by STAR VISION, which are compatible with its network and registered in the name of the subscriber.

(iii) To take proper care of STB of STAR VISION and intimate immediately in writing to STAR VISION, in case of loss / misplacement of VC with or without STB's. STAR VISION, shall thereafter. Within reasonable time deactivate the same. Subscriber shall continue to be liable for charges incurred on the said VC until it is reactivated. (IV) Not to use either before or after the STB (except TPWVD), any decoding, receiving, recording equipment(s) other than the equipment authorized and specified by STAR VISION

(V) To keep STB in good working condition, repairs replace STB from any agents or agencies authorized or nominated by STAR VISION

(VI) Not to remove or shift STB from the subscriber premises, without written consent of STAR VISION

(VII) Not to replace, sell, assign, pledge, mortgage, lend, underlet, shift, remove, exchange, modify, alter, misuse or tamper with the STB including the seat (see to prevent opening of STB) and VC. Any such act by the subscriber shall be construed as willful and criminal omission and /or commission on the part of the subscriber in addition to breach of its obligation in this agreement (VIII) To give all assistance, which STAR VISION may be reasonably expected to receive, in connection with this Agreement.

(IX) Not to indulge in piracy or activity, which has the effect of or which shall result into, infringement and violation of trader mark and copyright of STAR VISION, broadcaster, transmitter or any other person associated with such transmission.

(X) Not to distribute, disseminate, or divulge from subscribers premises to any neighboring premises (xi) intimate STAR VISION within two (2) days of receipt of bill /statement of subscription charge /charges, any discrepancies in billing (XII) Subscriber shall not be entitled to transfer or assign its obligations and liabilities mentioned herein to any other person /party under any circumstances, without prior permission of STAR VISION

(xiii) To deposit with STAR VISION, such amount as per the rental scheme/hire purchase scheme opted by subscribers interest free security deposit (XVI) To pay monthly rental charges/hire purchase charges to STAR VISION

(XV) To return STB to STAR VISION, on termination of this agreement, in good working condition.

(xvii) It the subscriber indulges (whether himself or in association with any other person), or causes any other person to indulge, in any offence pertaining to piracy (including infringement of any copyright, trademark, etc.) of any broadcaster or any other person STAR VISION shall have the right to deactivate the services of the subscribe, subject to applicable laws/rules/regulations for the time being in force and also have the right to terminate this agreement forthwith, such deactivation and the termination shall be in addition to the consequences and penalties elsewhere mentioned in this agreement (XVII) Any damage, loss, theft or STB/VC etc shall be an account of the subscriber and the subscriber shall be liable to make good such damage, loss, theft, etc. by paying the price of such STB to STAR VISION (XVIII) The agreement is personal to the subscriber and right of the subscriber shall not be assignable or transferable by him in favor of a third party. Any transfer or assignment effected in contravention of the expressed provision contained herein shall not absolve lire subscriber of its obligation/liabilities (XIX) Responsibility for payment of all taxes levies or charges, penalties, damage set etc imposed or under any statute, for the time being in force.

LIMITATIONS OF LIABILITIES

(I) It is expressly understood and agreed by the Subscriber that STAR VISION shall not have any obligation/liability whatsoever under this Agreement, towards the Subscriber on account of :- (a) any defect in SPE (including STB and/or VC) due to any unauthorized or improper use, replacement, removal, modification, tampering, misuse, negligence or failure to follow the prescribed instructions of STAR VISION (b) any action or failure to act default on the part of any supplier(s) of STAR VISION and/or its agent (s) or nominee (s), etc. (c) any delay or failure in performance of this Agreement caused by any reason or event beyond the reasonable control of STAR VISION (d) any indirect or consequential loss even if resulting from or caused due to any default on the part of STARVISION or any of its officers, employees, suppliers, distributors/franchisee agents or nominees. (a) deactivation of Services in terms of the agreement. (f) It is expressly agreed by the Subscriber that STAR VISION has not offered or provided, including but not limited to, the implied warranties of merchantability and fitness for a particular purpose and STAR VISION obligations with respect to the same except as set out in terms of this agreement. The Subscriber agrees that STAR VISION shall not be liable for any consequential, incidental, indirect, remote, economic punitive damage even if STAR VISION has been advised of the possibility of such damages. (4) The maximum overall liability of STAR VISION in contract, tort, or otherwise shall be to return the payment amount received, after adjusting the charges due from the subscriber. In no event shall STAR VISION, its Officers, Employees, Directors, Representatives and assignees be liable for any direct, indirect or consequential, damages, loss, costs, and expenses of whatsoever nature.

NON PAYMENT OF CHARGES AND BILL

(I) Without prejudice to such rights and remedies that STAR VISION may have in law or under the provisions of this agreement which inter BOO include rights to adjust the amount of security deposit against the arrears charges including subscription charges, rental for STBs, interest dues, d any, etc.. In the event of any delay or failure by the subscriber to pay the charges including subscription charges, rental, interest, etc. in accordance with the provisions of this agreement, STAR VISION shall be entitled to deactivate the service and at its option terminate this agreement in accordance with TRAI Regulations and to retain physical possession to the STB and the subscriber shall not object to the retaining of possession of STB by STAR VISION on such termination, the subscriber shall immediately return the said STB to STAR VISION provided however, STAR VISION at its discretion, waives its right to terminate this agreement, upon such a terms conditions as STAR VISION may deem fit and proper, which shall, inter-alia, include the receipt by STAR VISION (a) of the entire payment, as a subscriber is liable to pay pursuant to provisions of this agreement together with interest accrued thereon at the rate of twelve (12) percentage per annum from the date such amounts remain with the subscriber. (ii) they are fully paid; and (b) further charges as may be decided by STAR VISION at its sole discretion

(ii) Without prejudice to such rights and remedies that STAR VISION may have in-law or under the provision of this agreement, in the event of any delay or failure by the subscriber to pay the charges including subscription and other charges as per the bat (s) in accordance with the provision of this agreement. STAR VISION shall (in addition to the consequences mentioned in this agreement) be entitled to deactivate the service and at its option terminate this agreement in accordance with TRAI regulations and all sums due and payable by subscriber to

DAMAGES

(I) In case the contravention or violation of any of the covenants or Term and Conditions of this Agreement. STAR VISION shall have the right to Initiate appropriate legal proceedings civil and/or criminal charges against the Subscriber.

TERMINATION OF THE AGREEMENT

I) Subject to the applicable laws/rules/Regulations of TRAI, this Agreement shall automatically stand terminated on the occurrence of any of the following event or circumstances:- (a) if the Subscriber breaches any obligation or covenant under this Agreement or of any conditions under which the SPE was provided to the customer (b) if the Subscriber commits an eV of bankruptcy or becomes insolvent or bankrupt or makes an assignment for the benefit of creditors, or consent to the appointment of a trustee or receiver for the whole or a substantial pan of his/her property or appointment of trustee or receiver without his/her consent or bankruptcy, reorganization or insolvency proceedings instituted by or against the Subscriber voluntary or otherwise. (c) if STARVISION decides either suo motu or on the advice or request of a authorized cable operator, distributor, franchisee or other authorized persons of STAR VISION or bank/financial institution that has financed the SPE or on the advice of the insurance company or on the report submitted by an inspecting officer acting on behalf of STAR VISION to the effect that Subscriber has violated any Terms & Conditions of this Agreement to deactivate the Services permanently. (ii) Where the Subscriber signifies his/its intention to discontinue the Service, the following shall have been complied with:- (a) intention of the Subscriber shall be in writing and accompanied with the SPE, (b) the Subscriber shall have duly complied with all the Terms & Conditions of this Agreement and (c) all the bills, damages, Interest etc. shall have been paid in full by the Subscriber. In case of termination of the Agreement Subscriber shall surrender SPE to STAR VISION immediately without any delay. (iii) Where this Agreement has been terminated pursuant to this clause STAR VISION has the right to (a) proceed to enforce and protect its rights or recover any amount due and payable prior to termination and (b) enforce its rights to recover damages costs and other relief to which it may be entitled under this Agreement and applicable laws.

EFFECT OF TERMINATION / EXPIRATION

(I) Upon the termination of this Agreement save provided In this Agreement or by the operation of law, all rights granted to and obligations undertaken by the parties hereunder shall terminate immediately except (a) the Subscribers obligation to pay all amounts of bill accrued hereunder upon or prior to the expiration or termination of this Agreement and such additional amounts as specified In this Agreement and (b) Such other rights as may accrue to STAR VISION under this Agreement and/or under the laws of India. (ii) The Subscriber shall forthwith surrender the SPE In a functional condition to STAR VISION. (iii) The expiration or termination of this Agreement shall be without prejudice to the rights which have already accrued to the either parties under this Agreement.

INDEMNIFICATION

(I) The subscriber will indemnify and keep STAR VISION indemnified against all claims, demands, actions, proceedings, losses, damages, recoveries, judgments, costs, charges and expenses which may be made, or brought or commenced against STAR VISION or which STAR VISION may or may have to bear, pay or suffer, directly or indirectly due to any act, default or omission by the Subscriber

DISPUTE RESOLUTION

Every dispute difference or question arising in respect of this Agreement shall be referred to the sole arbitration by any person (including an officer or employee of STAR VISION) appointed by STAR VISION in its exclusive discretion and such arbitration shall be held in Puri/Bhubaneswar.

JURISDICTION
